ORDERS:

The Commissioner of Collegiate Education has forwarded the application submitted by the V.P. Muthiah Pillai Meenakshiammal Trust, Srivilliputhur, Kamarajar District to open an unaided private college in the name of V.P.Muthiah Pillai Meenakshiammal College at Krishnankovil Village, Srivilliputhur. The Commissioner of Collegiate Education has stated that the management has provided the following.

i. Dat. S.Palanisalvi, one of the Trustees of the above Trust, donated the innovable property of market value of Rs.20,14,500/- belonging to her to the above Trust and the same is registered in the Sub-Registrar Office, Srivilliputhur as Declaration of Trust in the joint name of Commissioner of Collegiate Education and V.P. Muthiah Pillai Meenakshiammal Trust in lieu of the endowment of Rs.10 lakhs in cash.

ii. The Management has acquired 11.52 acres of land in Villupaneer Village, Kamarajar District from Dat.S.Palanisalvi, one of the Trustees of the V.P.Muthiah Pillai Meenakshiammal Trust by way of Gift deed and the same is registered in the Office of the Sub-Registrar, Srivilliputhur.

iii. Agreement in stamp paper to abide by all conditions prescribed by the Government.

2. The Government have examined the proposal carefully and they permit V.P.Muthiah Pillai Meenakshiammal Trust to open a Women's College in the name and style of V.P.Muthiah Pillai Meenakshiammal Arts and Science College during 1994-95 at Krishnankovil Village, Srivilliputhur, Kamarajar District with the following courses.

1. B.A. Corporate Secretaryship
2. B.Com.
3. B.Sc. Computer Science
4. B.Sc. (Bio-Chemistry)
5. B.B.A.

3. The Management is permitted to start the college during 1994-95 at the permanent building already constructed in the land mentioned in para 1(ii) above.

4. The permission granted in para 2 above is also subject to the following conditions:

1. Affiliation from the Madurai Kamaraj University should be obtained for the college from the year 1994-95 and before the commencement of all courses of study.
2. The land mentioned in para 1(ii) above should not be utilised for any purpose other than college purpose.
3. The Government will not grant any financial assistance at any time.
4. The management should satisfy all the conditions prescribed in G.O. No. 858, Education, dated 15.7.89.
5. No other courses of study except Science, Arts and Commerce courses, allowed by the Government/University should be conducted.
6. The teaching and non-teaching staff shall be appointed as per the yardstick and they should possess the prescribed qualifications.
7. If the management creates a situation causing the closure of the college for any reasons, the Government will not come forward to take over.

The delay on the part of the management in submitting the application is condoned by the Government.


3. The Staff shall be paid the Scales of Pay as approved by the Madurai Kamaraj University and the Tamilnadu Government.
